**Note:-2** The candidates for the post of Assistant Professor for the subjects of Mathematics & Psychology are hereby directed to appear in the Commission's office for document verification followed by interview alongwith their application form, NET certificate (as claimed/uploaded), NET Mark-sheet, category-wise cutoff of marks for the said NET exam, all original Educational documents alongwith marksheet and Degree, one set of self attested photocopy of the said supporting documents and one passport size photograph etc. on the scheduled date and time mentioned above. In case of candidate who have claimed Ph.D degree. They are hereby directed to submit a compliance certificate that their Ph.D Degree is in accordance with the University Grant Commission (Minimum Standards and Procedure for Award of M.Phil / Ph.D Degree) Regulation, 2009 or 2016 as amended from time to time, as mentioned in the advt. The said certificate should be signed by Registrar or Dean (Academic Affairs) of the University as mentioned in the advt. otherwise, Ph.D degree will not be considered.

In case any candidates who fail to submit above said documents appear in the Commission's office on the scheduled date and time for document verification followed by interview, then the Commission will take decision regarding their eligibility based on their available record. As per clause 16 (vii) of the advertisement, no document which have not been uploaded will be considered.

Further, in case of candidates from reserved category of Haryana or other State candidates, they will submit proof regarding all eligibility conditions i.e. age, educational qualifications, good academic record meant for the General/UR category including National Eligibility Test for Assistant Professor qualified by them is in the General/UR category alongwith (a) NET certificate (as claimed/uploaded), (b) NET Mark-sheet, (c) category-wise cutoff of marks for the said NET exam etc., for being considered in General/UR category otherwise they will be considered in their own category if found eligible.
